BOOTH ASSIGNMENTS

Exhibit space will be given in the order in which the contract and check are received. First come, first served. All contracts must be made on the enclosed application. Exhibitors who wish to avoid a certain competitor should indicate so on their application. MPhA reserves the right to relocate any booth. Each booth measures 6' deep, 8' wide with backdrop, side dividers, skirted table and 1 chair.

****CONVENTION POLICY**

Everyone attending the MPhA Convention must be registered as a pharmacist, guest or an exhibitor in order to get in the exhibit hall, continuing education programs, and any events at the convention. Nametags and tickets are required.

CANCELLATIONS

SECURITY

MPhA will provide security to **close** the exhibit hall. Additional security may be obtained directly by contacting the hotel facility. It is the exhibitor's responsibility to ensure that items within its own booth are guarded or stored. The exhibit hall is locked after each display time, and no one is allowed in the exhibit area after display times.
